**Expedited Courier Service** – to avoid USPS Postal Delay/Slowdown of regular mail. For faster shipping delivery & return of your document through the to the Department of State, you can select one of the following options. Otherwise, our standard shipping method of USPS Priority Mail will be used. Selecting the FedEx option will save you about 4 -10 business days.

Fedex Priority Overnight/USPS Express Mail \$ 60

**Returning or Forwarding your document(s) to any USA address** - Your document will be returned to you or forwarded to any USA address using USPS Priority Mail. Its cost is included in the above price. However, you can select overnight shipping for faster delivery of your document(s).

USPS Express Shipping \$ 30 or  FedEx Priority/Standard Overnight Express \$ 50

## Additional Information

### Processing Time

Please note, because of the Corvid-19 Pandemic, document processing at the US Department of State, (USDOS), is taking 25 business days or longer. We do not have any control over how long it takes. The time frame is the same for all companies that offer FBI apostilles.

We all rely on the US Department of State for an FBI apostille. No local courier service is any faster as the USDOS works on their own schedule depend on volume of work they receive, staffing issue because of pending holiday breaks or weather. The estimate processing time does not consider the time spent in the postal mail system which can vary due to the political delay / slowdown of mail delivery. If you wish faster mailing, I suggest selecting the option for FedEx service, or USPS Express mail. Otherwise, all mail is we sent is using USPS Priority Mail with tracking.

### Translation Service

Translation services is an additional service that we provide, please fill out the [Professional Translation Form](#). The translation will be done once the document apostille service is completed. The translation will include 1 additional page in the translation, which is the FBI apostille page. So, make sure you select 1 additional page otherwise the number of pages translated will be processed as you have selected. The translation will be done once the document apostille service is completed.
