Please note this order form is for calculating the cost for a Courier or Mobile Notary Public to come to your home, office, or a mutual location.							
The Courier Service is for picking up & or delivering documents to a client and the Mobile Notary Service - we will travel to your location to notarize your document at your location, so you will not have to travel. The previous services consist of several options that depend on what additional services you need. To calculate your fee, your need to select a Base Rate for the time of day the service will be provided, then add the Travel Fee for the number of miles to your location, then add the Notary Public Fee of \$2 for each page that requires a notary stamp, (not the total number of pages in your document). You can then add additional service fees such as Printing, Faxing, Scanning, Copying or Emailing document. Please note, the notary has a schedule with other clients to meet up with. In order to be efficient, economical & productive with the notary's time, there is a fee for additional Waiting Time to ensure the notary arrives in a timely manner for his next clients' appointment. Therefore, Notary appointments are in 15 minutes time blocks. So, if your session runs more than 15 minutes or you need to schedule more time, then each additional time block of 15 minutes or less is an additional \$15. Once you filled out this form, sent to the above email address, wait for confirmation or call to confirm date & time. You must receive confirmation on the date & time.
