APOSTILLE SERVICE

NEW YORK STATE APOSTILLE - URGENT/ RUSH SERVICE (Same Day Service with an 8-hour Guarantee process) **\$295** for the **first document**. All additional documents are **\$68 each**. Certain criteria & conditions apply, see below.

Same day RUSH Service depends on the location of the document if a pick-up is requested, the amount of work required to get the document to an apostille ready state & the time document is received.*

NEW YORK STATE APOSTILLE - RUSH SERVICE NEXT DAY / SERVICE - Turnaround time: **2** business days
The first document is **\$220**, All additional documents are **\$68 each**.

NEW YORK STATE APOSTILLE - STANDARD PROCESS SERVICE – may take up to **3** business days to complete before it is return via mail. The first document is **\$175**. All additional documents are **\$68 each**.

NEW YORK STATE APOSTILLE SERVICE - BY MAIL ONLY: May take up to 12 business days to complete.
All documents are **\$99 each**, each additional document is **\$99 each**.

ALL OTHER USA STATES APOSTILLE - STANDARD PROCESS SERVICE – may take up to **10** business days to complete.
The first document is **\$195**. All additional documents are **\$95 each**.

MAIL:

If you are a business, you probably have access to a pre-paid air bill, you can send a pre-paid FedEx or UPS air bill to have your document returned to you or forwarded to someone else. If you are unable to send a pre-paid air bill, please send \$3 extra to cover a large First-Class envelope. If you are not in the USA, please do not send pre-paid postage stamps from your country as they are not acceptable in the USA. USA clients can send a Self-Address Stamped Envelope with enough postage to cover 1 document of 3 pages or more if you're having more than 2 document process.

For Courier service using **FedEx International, USPS Priority, USPS Express Domestic or International** are additional costs.

ALL OTHER STATES - STANDARD PROCESS SERVICE – may take up to **10** business days to complete.
The first document is **\$195**. All additional documents are **\$95 each**.

LEGALIZATION - Additional work will be required if your document has to go to a country that is not part of the [Convention of 5 October 1961 Abolishing the Requirement of Legalization for Foreign Public Documents](#). Legalization, requires your document to be sent to Washington, DC for additional processing.

FEDERAL DOCUMENT – Such as FBI background check, Free Sale, FDA, USDA, USPTO, EPA Homeland Security also require your document to be sent to Washington, DC for additional processing.

* *Personalize door to door, hand courier pick-up & delivery service maybe provided for this service if you are within our local service area, otherwise an additional pick-up & delivery fee will apply according to the distance from our office with a minimum of \$38.*
